Job Summary / Main Purpose:

To provide full administrative, secretarial and co-ordination support to the Clinical Coordination Centre , under the guidance of the Clinical Coordination Admin Team Leader. To provide administration support and cross cover to other clinical areas within the Hospice environment when required.

Administrative/Secretarial:

- To access and maintain patient databases Access and Systm1, including housekeeping for other clinical teams within Dorothy House (DH).
- Produce the weekly death list
- To receive and record referrals to Dorothy House (DH) ensuring that detailed and accurate information is taken and documented accurately on Systm1.
- To access and monitor NHS referral email accounts and department email accounts.
- Receive telephone calls and messages and provide compassionate communication to distressed patients and families. Listening and providing comfort and sign posting to other services.
- To receive and record accurate messages, determining whether immediate action is required and relay any messages to DH Teams using Teams and Systm1.
- To organise meetings including preparing agendas, room booking arrangements and taking minutes as required.
- To collect information for, prepare and circulate the off duty rota for the DH Nurse Specialists as required.
- To help with data collection, reporting and spreadsheet creation as part of the ongoing monitoring of the services.
- To type letters, reports, tables and any other documentation.
- To prepare presentation materials using PowerPoint and Word.
- To liaise with the Medical Secretaries, members of the Primary Health Team and others, to request information and clinical reports, as required.
- To use Itrent database to support team functions.
- To report any safeguarding concerns to the Clinician on duty within the CCT and seek support from the Clinical Lead for the CCT.




General Administration:

- To take calls from patients and carers who may be distressed or where there are communication issues, responding promptly and efficiently in a courteous manner and refer on as appropriate.
- To communicate at all times with compassion and professionalism
- To liaise closely with staff members within DH, flexibility working across teams and supporting the administration of all clinical services.
- To listen and respond to any concerns and/or complaints from patients, families or professionals, informing the Clinical Lead Clinical Coordination Team, or in their absence the Director of Patient and Family Services, and record the concerns, follow-up and outcome in line with the Complaints Procedure.
- Support the training of new staff ensuring they have the necessary resources to commence work.
- To provide cover when required to the Clinical Coordination Teams and other clinical areas

Professional:

- To promote and adhere to DH values (behaviours, caring, dignity and respect, learning and reflection, commitment to quality care and support)
- To take an active contributing role in the planning, provision and development of audit/evaluation of the service, clinical audit, quality assurance programmes and educational programmes.
- To be aware of the budget allocated for the service.
- To record and report any accidents, incidents and near misses that happen to the staff during the course of their duty.
- To attend meetings as appropriate.
- Work within the policies and procedures of DH.
- To engage in receiving regular Group Clinical Supervision by attending at least 8 supervision sessions per year.
- To take responsibility for own personal development and education and identify development needs with the Clinical Lead of CCT.
- To undertake mandatory training as required for the job role and participate in an annual PDR.
- To work within a 7-day service –between the hours or 8am 18.00pm within an agreed roster, supporting the advice line.
- To provide cover or carry out additional duties in the absence of other administrative staff as required.
- To listen and respond to any concerns and/or complaints from patients, families or professionals, informing the Clinical Coordination Admin Team Leader.
